SUBMISSION INSTRUCTIONS

(Please read carefully. Following these directions can help expedite your order.)

1. Please print your name, dealer/club number, legal address and passport information, email address, VAT number and phone number in the space provided. Grading fees do not include VAT. You must be a PCGS Authorized Dealer or Collectors Club member to submit coins. If you are not a Collectors Club member you may elect to join on this form for 69€ per year.

2. Package Information (required) — Be sure to completely fill out this information.

3. Select Type of Submission desired. **ONLY ONE TYPE OF SUBMISSION AT ONE SERVICE LEVEL IS PERMITTED PER SUBMISSION FORM.**

All coins determined to be genuine will be encapsulated in our scratch resistant PCGS holder.

DEFINITIONS

GRADING: For raw coins (not encapsulated), you may, but are not required, to specify a minimum acceptable grade. Coins graded below the minimum acceptable grade will not be holdered; however, the full grading fee will be charged.

REGRADE: For a coin previously graded by PCGS you feel might be worthy of a higher grade, submit it in the holder. The coin will be removed from the PCGS holder and regraded. If the coin grades lower, the terms of the PCGS Guarantee will apply. For full disclosure on the PCGS Guarantee, visit www.PCGS.com/Guarantee/html.

CROSSOVER: For a coin previously graded (currently encapsulated) by another grading service. Minimum Grade: PCGS will holder the coin only if it meets or exceeds your specific request noted in the Minimum Grade column on the front of your form.

Grading fees will apply whether the coin crosses or not. Coins that do cross will also be charged a Guarantee Premium based on the value of the coin.**

Please specify one of the options in the minimum grade column. If you leave this area blank, PCGS will assume the minimum grade is the grade currently on the holder.

REHOLDER: Re-encapsulation of PCGS-graded coin. Coin will not be regraded.

GUARANTEE RESUBMISSION: If you have a PCGS-graded coin that you feel is overgraded, misattributed, or counterfeit, submit the coin to PCGS through the Guarantee Resubmission Service. A fee of 25€ per coin must accompany all submissions through this service. If your coin is downgraded, the terms of the PCGS Guarantee will apply and all fees and charges related to the Guarantee Resubmission will be refunded.

****GUARANTEE PREMIUM:** Equal to 1% of the value of the coin in its final grade. The value of the coin is determined by the PCGS Price Guide value for that grade or the Declared Value of the coin, if the Price Guide value is not available. The minimum amount for the Guarantee Premium is 5€. PCGS reserves the right to make the final determination of the coin's value.

4. Select one of the three options for Genuine Service. Only one option is allowed per submission form; 1. Genuine with Details (default) 2. Genuine no Details 3. Do not holder Genuine-only coins.

5. Select Service Level by referring to the PCGS Services and Fees on the front of this form. Note minimum requirements and other restrictions.

6. List each coin's description. For multiple coins of same date, denomination and variety, you may list total quantity and write on one line. For the date of each coin, include mint mark. If coin

is a commemorative, list name of issue. List denomination of each coin (ex. 1c, 1, 10). Indicate Declared Value for each coin. If no value is assigned, you authorize PCGS to assign a 50€ value per line or the minimum amount allowed by the service level selected, whichever is higher. Tokens and Medals should be submitted under the appropriate service level based on their declared value. For a list of eligible Tokens and Medals we certify, please refer to www.PCGSeurope.com/Services/Medals.

7. Calculate Grading Fees — This includes any additional services and fees (oversized holder, TrueView, and Guarantee Premium).

8. Total your charges and mark Method of Payment. Include payment information. You must include payment or your order will not be processed.

9. Read Terms and Conditions. Sign and date bottom of form. Order will not be processed without signature. Keep gold copy for your records.

10. Place each coin in a new 6.35 cm x 6.35 cm plastic flip with submission form and line number listed. Do not send coins with staples. Package coins and submission form carefully.

11. Coins can either be delivered in person to the PCGS Paris Submission Center (by appointment only) or shipped directly to us. Mail coin submissions to Collectors Universe (PCGS) 92 rue de Richelieu, Esc G, 2nd Floor, 75002 Paris, France. We do not accept shipments via Post Office (either Registered or Secured mail). Submissions can be sent via courier of your choice, or delivered in person to the PCGS Paris Submission Center. 12. Graded coins will be held at the PCGS Submission Center until picked up, unless return shipping has been previously arranged with PCGS.

PCGS GRADING TERMS & CONDITIONS

By signing the front of this form, customer acknowledges that they have read the Collectors Universe (Paris) Limited-PCGS ("PCGS") Grading Terms and Conditions (the "Agreement") set forth below and agrees to abide by this Agreement, and further agrees that PCGS is entitled to rely upon and benefit from this Agreement.

1. PCGS will endeavor to grade coins within the time frame, if any, offered as part of a PCGS grading service. However, PCGS will have no liability whatsoever to the Customer for incidental or consequential damages due to PCGS' failure to grade any coin within any time frame.

2. PCGS will not grade coins which bear evidence of harsh cleaning, artificial toning, damaged surfaces, excessive major marks, minor planchet flaws, altered surfaces, PVC damage, Doctoring or similar impairments. If PCGS rejects any coin for grading in accordance with PCGS's grading standards and procedures, PCGS shall not refund the fee paid by Customer. Customer represents and warrants that it has no knowledge and no reasonable basis to believe that any coin submitted for grading has been altered or Doctored in any way. For purposes of this Agreement, "Doctoring" shall have the meaning set forth in the applicable PCGS Authorized Dealer Agreement or PCGS Collectors Club Agreement by and between Customer and PCGS (the "Customer Agreement"). If Customer has not entered into the Customer Agreement, Customer hereby agrees to be bound by the terms of the Customer Agreement, a copy of which can be found at www.pcg.com, and Customer's signature on this Agreement shall constitute Customer's acceptance to be bound by the terms and conditions of Customer Agreement including its obligations with respect to Doctored coins set forth in the Customer Agreement. Customer warrants that all information provided herein is accurate and reliable and undertakes to promptly correct and update such information if Customer discovers any such information is inaccurate.

3. Grading involves individual judgments that are subjective and require the exercise of professional opinion, which can change from time to time. Therefore, PCGS makes no warranty or representation and shall have no liability whatsoever to Customer for the grade assigned by PCGS to any coin, except pursuant to PCGS's Guarantee resubmission as set forth on PCGS's website at www.pcg.com which by signing this agreement the Customer acknowledges he has read and accepts the terms and conditions of the PCGS Guarantee.

4. PCGS will exercise reasonable care in handling coins submitted for grading, regrading or reholdering. However, if PCGS determines that the Customer's coin was lost or damaged while in PCGS possession, Customer will be compensated based upon the fair market value of the coin as determined by PCGS standard procedures which may include filing a claim with our insurance carrier. The declared value you stated on the front of this form is for estimating the insurance coverage only, and the fair market value of the coin may be less than your declared value. **IN NO EVENT SHALL THE TOTAL LIABILITY EXCEED THE DECLARED VALUE OF THE COIN.**

5. Customer must inspect all coins immediately upon receipt and PCGS disclaims any liability for damage or discrepancies (such as errors pertaining to the description of the coin) unless reported to PCGS within five (5) business days of Customer's

receipt of the coin(s). Customer agrees to return any incorrectly described coin to PCGS upon request for correction and agrees to indemnify and hold PCGS harmless from any and all losses and/or claims caused by the circulation or sale of any incorrectly described coin. Repeated failure to report such errors may cause suspension or expulsion of membership from the PCGS Authorized Dealer Network.

6. Customer agrees (a) to pay PCGS all fees and other charges when due; and (b) that any delinquent balances shall accrue interest for late payment at the rate of 3 times the French legal interest rate.

7. PCGS shall have no liability whatsoever to Customer, or any third party for whom Customer may be acting, for (i) any personal injury or (ii) for any damage to any coin, or otherwise, that Customer is unable to demonstrate was attributable primarily to an act or omission to act by PCGS while the coin was in its possession and control, except for any damage to a coin resulting from the breaking open of a PCGS or other coin holder in which the coin may have been submitted for grading to PCGS.

8. Note all terms and conditions are subject to change. Turnaround times do not include mailing time and reflect business days.

9. Except as expressly set forth herein to the contrary, PCGS DISCLAIMS ANY AND ALL WARRANTIES, EXPRESSED OR IMPLIED, REGARDING PCGS' GOODS AND SERVICES, INCLUDING BUT NOT LIMITED TO THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

10. Notwithstanding anything to the contrary contained herein, except with respect to the remedies under the PCGS Guarantee of Grade and Authenticity set forth at www.pcg.com (the "Guarantee") and as set out in paragraph 4 above in connection with the loss or damage to a coin while in the possession of PCGS THE MAXIMUM AGGREGATE LIABILITY THAT PCGS SHALL HAVE TO CUSTOMER, OR ANY THIRD PARTY FOR WHOM THE CUSTOMER MAY BE ACTING, ARISING FROM ANY CAUSE, ACT, OMISSION OR OTHER CIRCUMSTANCE, SHALL IN NO EVENT EXCEED THE GRADING FEE OR AMOUNT ACTUALLY PAID BY CUSTOMER FOR THE GRADING SERVICES RENDERED BY PCGS WITH RESPECT TO THE COINS SUBMITTED FOR GRADING HEREUNDER. IN NO EVENT SHALL PCGS OR ANY OF ITS AFFILIATES, OR ANY OF ITS OR THEIR RESPECTIVE EMPLOYEES, OFFICERS, DIRECTORS OR AGENTS, BE LIABLE TO CUSTOMER OR ANY OTHER PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

11. In the ordinary course of its grading operations, PCGS (i) compiles data regarding each coin submitted for grading, including, but not limited to, data relating to the identity, minting, condition and grade of the coin (the "Data"); and (ii) may take, or have taken, one or more digital or other types of photographs, images or reproductions of each such coin (collectively, the "Photographs"). In consideration for the grading services being provided by PCGS, Customer, on behalf of itself and any third party for whom Customer may be acting, hereby authorizes PCGS (i) to compile and maintain such Data with respect to each coin submitted hereunder for grading; and (ii) to take, or cause to be taken, one or more Photographs of each such coin, and further agrees that PCGS will be the owner of such Data and all such Photographs

and that PCGS may use and exploit such Data and the Images for commercial and any other purposes, as PCGS in its sole discretion deems appropriate, including, but not limited to, the publication and republication or reproduction in or on any media, of such Data and Photographs.

Without limiting the generality of the foregoing, Customer, on behalf of itself and any third party for whom Customer may be acting with respect to this agreement, unconditionally and irrevocably transfers, conveys and assigns to PCGS any and all current and any hereafter acquired rights, title and interests (including, without limitation, rights in copyright, patent, trade secret and trademark) that Customer or any such third party may have in or to the Data and the Photographs (on whatever media or in whatever form such Photographs may be reproduced or published).

12. If any coins are being submitted for a third party, Customer represents and warrants that (i) such third party has been provided with a copy of the Customer Bill of Rights and these PCGS GRADING TERMS AND CONDITIONS and (ii) such third party has agreed and accepted these PCGS GRADING TERMS AND CONDITIONS and has signed a duplicate copy hereof where indicated. Customer agrees to provide that third party-signed copy to PCGS at any time upon its request.

PCGS REFUSES TO ACCEPT ANY RESPONSIBILITY, AND THE CUSTOMER HEREBY WAIVES ALL CLAIMS AGAINST PCGS, IN THE EVENT OF ANY ATTACHMENT BY A CREDITOR OF THE CUSTOMER OR SEIZURE BY ANY GOVERNMENT AUTHORITY OF ANY COINS SUBMITTED TO PCGS IN CONNECTION HEREWITH.

13. It is further agreed as follows:

These Terms and Conditions shall be governed by the laws of France. Exclusive jurisdiction shall be granted to the Commercial Court of Paris for any dispute relating to these Terms and Conditions. Customer accepts and agrees not to challenge the jurisdiction or venue of such Court or assert that it is not a convenient forum. The terms and provisions in this PCGS GRADING TERMS AND CONDITIONS constitute the entire agreement of PCGS and Customer (and any third party for whom Customer may be acting) regarding, and supersede all prior agreements and understandings (written or oral) between or among such parties relating to, the subject matter hereof. If any term or provision of this agreement is determined, by a final and non-appealable ruling or order of a court of competent jurisdiction, to be invalid or unenforceable under applicable law, such invalidity or unenforceability shall not affect the validity or enforceability of any of the other of the terms or provisions of this agreement. Each party shall execute and deliver such additional documents and instruments as any other party may request to better evidence or effectuate the agreements contained herein, including the assignment of rights set forth in Section 12 above, and procedures, and further agree that PCGS is entitled to rely upon and benefit from those terms and procedures.
